As I mentioned earlier on the phone I was in the middle of a "tax update" when you called. Here is some more detailed info regarding the questions I couldn't answer earlier.

1. First, a little context. As I mentioned, I felt two-thirds of the questions shouldn't have been directed to me. Let's please get a good tax director. I will forward Lisa C's resume to both of you under separate cover. Of the remaining 1/3 I am embarrassed that I didn't have better/more comprehensive answers to most....but that was the point of the tax update meeting I was in. Substantively:

2. Foreign disclosure statements due 10/15. Tom preparing currently and we'll get a date to jeffrey when he can see them.

2. 1099 roll-up schedule of all 1099 income from all sources that gets incorporated into 1040 and due 10/15. Almost complete (w/back-up) and jeffrey can have early next week.

4. Use tax schedule. Done. Jeffrey can have by friday.

5. Regan Arts--advance and inventory review underway w/ BDO, John Murphy and Judith. 6 hrs of work; no sensible reason why we waited so long though not done until 10/15. Will get a date that we'll get to Jeffrey.

6. Artspace--done; gets rolled into 1040.

7. Phaidon--

a. Capital losses associated with sale--done.

b. Operating loss gets stuck in UK entity.

c. Ldb interest income on notes--done.

d. There was/is an issue w/200k of PW legal fees that just came in recently--regarding 2015 transaction that has a tax effect. I really don't yet understand fully, but it appears simply mismanaged by RJ/office.

7. Avionetta--w/tom; shld have a draft by end of week. Timing of financials --impacting timing of tax returns) mismanaged by office.

8. 9/15 projection and estimated taxes. Hasn't moved much from June estimate. Should have by Monday even though we won't have all k-1's. Like=y paying in around 2.3mm on NYS.
