I checked again with my assistant and she assures me that she has not had any conversation with you or message from you all week, so I am mystified by your assertion that you have left messages for me, but the information I am still looking for is noted below, in our exchange from yesterday. It is (a) information about Noam's income (so I can understand what portion of his expenses can be met from sources other than the trusts), (b) what period the tax payments made from the trust in 2017 covered and what the \$300K covers, and (c) what additional medical expenses have been (though I understand that the nature of those expenses is subject to confidentiality).

Harry's attorney would like to communicate with you and/or Noam's attorney to discuss how to move forward on my replacement, as well as about a more global settlement.

2. There is no reference to "daily =iving" costs. Can you ballpark a monthly figure for that =clothing, groceries)?
3. Please break down the tax figure for =e. What portion of the \$260,000 figure is 2016 taxes paid in =017, what portion is 2017 taxes and what portion is estimated payments =owards 2018 taxes. Please also tell me how the figure reconciles =ith the tax payments (\$180K) in all that we made on Noam's =ehalf in December of 2017.
