iii. The Seller is the sole owner of the Work and has full legal authority to transfer good, valid and marketable title to the Buyer, and to complete the transaction contemplated herein.

iv. The Seller has good, valid and marketable title to the Work, and the Work is, and at the time of transfer of title will be, free and clear from any and all rights or interests of others, claims, liens, mortgages, security interests, restrictions, conditions, assessments, exceptions, options, equities or other encumbrances of any kind held or claimed by any person or entity (collectively, "Claims").

v. The Seller has no knowledge of any Claims threatened or pending, nor any knowledge of any facts of circumstances that he deems likely to give rise to any Claims.
