NOTES

For the 3rd state there is one trial proof as well as the 15 numbered proofs. The wide etched lines made with a scraper were grained with aquatint before being bitten in order to make them darker.

Only the IIIrd, the Vth and the VIIth states were printed in 15 proofs.
