Dear Rich,

Following our phone discussion with Mr. Epstein, I would like to inform that before we send somebody to SVI, we ask you to carry out the following activities:

1. Please send a picture of the boat laying on the water taken from the side - so we see the trim of the boat
2. Please check if the bilge plug (in the lowest point of the transom) is correctly fitted - that there is no water ingress
3. As I understood, the boat is making noise even when it is not cruising?
4. I also understood that you had covered the entrance to the bow compartment in order to check if the sound difference?
5. Please send the model of Yamaha engines mounted on the boat

If the video's sent by you few days ago give the actual sound reception, then this sound is not untypical for a RIB cabin boat.

However in order to soundproof the cabin, we suggest to cover the place where you stand in the bow compartment with a foam block and additionally mount a door at the entrance.
