It was good to talk to you earlier t=is week and as I said I completely understand your concerns and frustrations as does the Duchess. We discussed a number of ways of trying to rectify this situation including:

- Public comment by the Duchess in forthcoming US TV interviews
- A statement from her
- A letter from her<=p>

In reviewing these options there is a concern that any comment "live" and "on air" might generate more negative than positive for you, in terms of follow on questions, therefore a letter of clarification – as suggested by you – would be more appropriate.
