I watched the video and they refer to a "galley annex" which is customarily the L/H galley.

Based upon my experience, I am comfortable placing a gentlemen's bet that the coffee makers are outboard of the two pocketing doors above the microwave oven in the L/H Galley "annex" and the oven is likely located in the lower section of the same galley or perhaps the lower of the R/H galley.

I am confident that the lavatory is the standard configuration with one closet each directly adjacent to the aft lavatory vanity and the aft lavatory toilet assembly.
