Dear Mr. Barnett:

Pursuant to our recent survey the following is our proposal to provide and install the following equipment and services.

### SCOPE OF WORK

- ❖ Disconnect, remove, and dispose of the old 40-ton Carrier chiller from basement mechanical equipment room.
- ❖ Provide, rig and install (1) new additional 30 ton Multistack module to attach to the existing chiller.
- ❖ Disconnect, remove and dispose of old BAC Cooling towers and remote sump.
- ❖ Provide, rig and install (2) new 52-ton BAC galvanized cooling towers to roof and pipe into existing condenser water system.
- ❖ Provide, rig and install (1) new remote sump (galvanized) in basement mechanical room and pipe into existing condenser water system.
- ❖ Change filter media on existing sand filter.
- ❖ Provide protection to entrance hall and steps for deliveries.
- ❖ All necessary materials and labor to pipe chiller.
- ❖ All necessary materials and labor to install power wiring for chiller.
- ❖ Insulation of all new chill water piping and damaged insulation that may be disturbed during tie in of components.
- ❖ Chill water and condenser water balancing.
- ❖ Rubbish removal and carting away from site
- ❖ Factory supervised start-up, and one-year warranty on entire project.
- ❖ Five-year warranty on new compressors (Part only)
- ❖ All labor and supervision to complete the above scope of work.
