See attached revisions to the draft Petition suggested by Alan. Alan has the same view I shared with you earlier (better not to mention grantor trust status and flag Rothstein) but noted that if you wish to highlight grantor trust status, the attached language is more appropriate. "Irrevocable defective grantor trust" is merely a term of art used by planners and is not in the tax code.
