Remote control has similar functionality to Logitech Remote, with the add bonus it can handle the Sony 4k media player. At present you have a Tablet to control media player and a Logitech Remote for Apple TV, BD etc.

Larry indicated you were considering running L&R Front Highs  
Constellation Audio advised, McIntosh MX121 has 7 channels, if you wish to run L&R Front Highs it would require giving up a back surround Channel.
