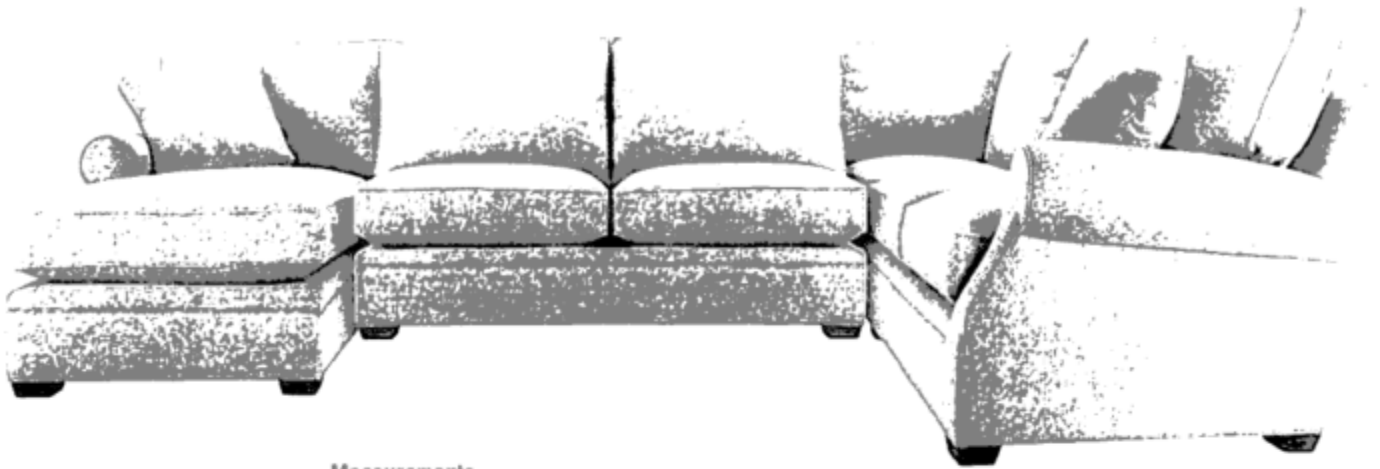

## fabric

- ▶ Stocked in Theater Gunsmoke, this piece reflects a surface of misty greys—making it a perfect canvas for endless style and decorating options.
- ▶ The stocked Theater Gunsmoke fabric is a woven blend of polyester and acrylic, known for its durability and comfort.
- ▶ Choose from 5 additional Theater fabric colors, as well as 14 additional fabric selections for the same price as stock.
- ▶ Our Landsbury 3 Piece Sectional is also available in more than 500 designer-inspired fabrics, for a slight increase in price.

## finish

- ▶ Slightly tapered block feet are crafted from solid wood in a flannel finish, or you may choose from 15 other shades to complement your existing wood pieces.
- ▶ To perfectly accommodate any size living space, our Landsbury collection is available in 30 additional pieces by special order.

## construction

- ▶ Built from kiln-dried, cross-directional hardwood laminate for lasting strength and stability so it will not change shape due to changes in temperature or humidity.
- ▶ Strong, durable and earth friendly, the frame is constructed entirely from wood that has been certified by the Sustainable Forest Initiative, an organization that maintains the standard in the preservation and protection of natural forests.
- ▶ All joints are corner blocked and glued, then doubly reinforced with mortise and tenon construction to guarantee years of structural reliability. Mortise and tenon assembly is one of the best ways to secure two pieces of wood that connects at a "t." The end of one piece is fashioned into a round or rectangular shape (tenon), which is designed to fit into the same size hole on the other end (mortise).

- ▶ Cushions are sustained by a steel suspension system secured with heavy-duty, 11-gauge helical coil springs that are made of 95 percent recycled steel and aluminum.
- ▶ The seat cushions feature a 2.0 density foam core topped with an eco-friendly foam wrap consisting of more than 20 percent plant-based material and are encased in layers of soft Dacron plus an abundance of fibers, feathers and down to deliver an irresistibly soft and cozy feel.
- ▶ The entire insert is enfolded in sumptuous down/fiber blend that is channel stitched into a down-proof ticking to create that irresistible "sink into" feel while maintaining the cushion's shape through years of use.

## recommended care

- ▶ Theatre Cleaning Code: S.
- ▶ Spot clean the fabric with a solvent-based cleaning product.
- ▶ For overall cleaning, consult a professional upholstery cleaner.
- ▶ Buff legs occasionally with Guardsman's Furniture Polish.
- ▶ Do not over-wet.
- ▶ All fabric may fade over time. Wearability of fabric is relative to care and use.
- ▶ We also recommend flipping the seat cushions periodically and avoiding direct exposure to sunlight.
- ▶ Rotate cushions periodically to distribute wear.



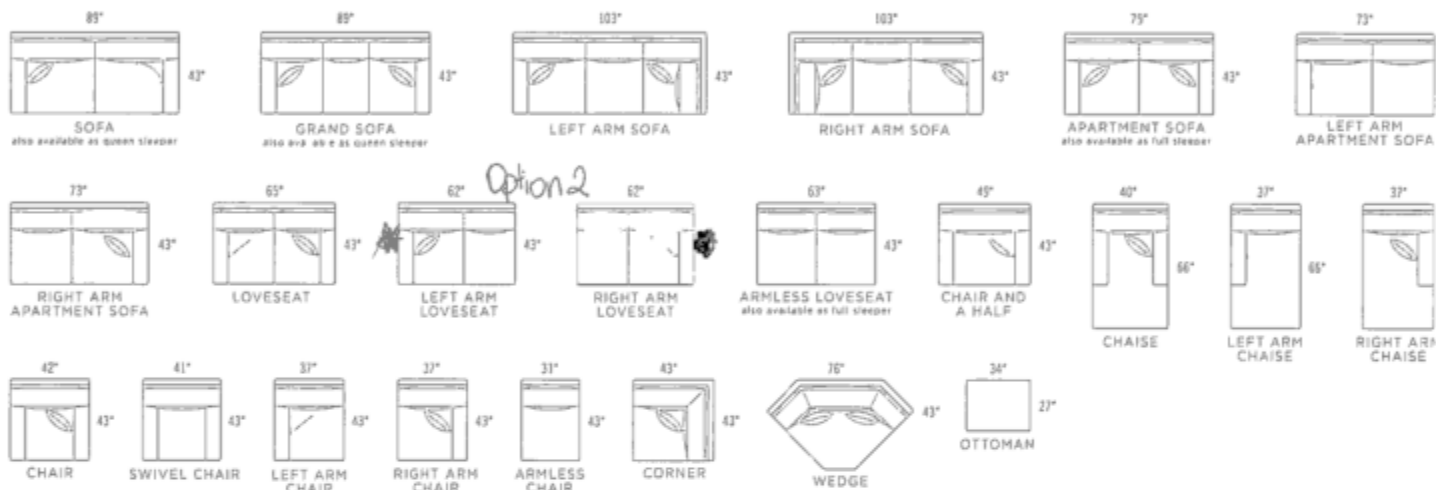
