Principle accomplishment: The initial two assets (Ritz San Juan and the Ambassador Plaza) that he has been associated with over the past two years improved EBIDTA from 12 million per annum to \$26 million per annum. He has conceptually put together packages of different restaurant franchises in these hotels to make the hotels focal points of the communities that are located in as well as the "eye" of the U.S. travel community. He was involved in the repositioning of the Marriott Hotel in Aruba by bringing many of his best practices into play to make this a world-class destination resort. Reporting to the President; Mr. Cortese was responsible for all operations of 1,500-room hotel and two sister hotels, The Ocean Club and Paradise Paradise Hotel, as well as a 45,000 square feet Casino, an 18-hole Championship Golf Course, and in addition to this he oversaw the airport operations which had 262,000 arrivals per year plus a Marina. He also oversaw the “reverse-osmosis” water treatment plant and a sewage treatment plant.

This property went from \$2 million in EBIDTA to \$85 million in EBDITDA in two years. Although Mr. Sol Kerzner had the vision and did the investing it was with Mr. Cortese leadership the results were obtained. *His* decision in leaving Atlantis Resort was due to a change in Mr. Sol Kerzner’s business direction, from a resort destination to a gaming destination. This subsequently failed to succeed and has returned to being a world-class resort destination.
